MOUNTVILLE BOROUGH COUNCIL MEETING MINUTES November 13, 2023

A meeting of the Mountville Borough Council was held on Monday, November 13, 2023, at 1900 hrs. in the Mountville Borough Hall at 21 E. Main Street, Mountville, PA 17554.

The following Council members were present:

- Also, present were West Hempfield Township Police Chief Lisa Layden, Mountville Fire Co #1 Chief Dean Gantz, Jr., and Borough Manager Derrick Millhouse.

The meeting was called to order at 1900 hrs. by Council President P. Kresge who then gave an invocation and led the Pledge of Allegiance.

President Kresge addressed the visitors in the room. He advised them of the public comment sections of the meeting, and if anyone wished to be heard during those times, they could stand, state their name, and address, and then address the Council.

• Claudia Shank, an attorney representing F.O.S. Properties, commented that she is present to make sure the closure of the Spring Street rail crossing would not affect the operation of Field of Screams.

Recognition of Visitors

Norfolk Southern – Alex Ricci from Norfolk Southern was present in case Council had any further questions about
the closure of the Spring Street rail crossing. He also notified Council they would now receive \$30,000.00 in
incentives if the crossing is closed, which is an increase from the \$17,500.00 previously reported. Alex provided
an explanation of how and where the physical barrier would be placed and addressed the concerns of Ms. Shank
regarding the parking lot entrance to F.O.S.

- Chairperson Spiegel recognized Mountville Fire Co #1 Chief D. Gantz who presented the monthly report that was distributed to Council earlier.
 - o The fund drive has raised just over \$38,600.00 so far.
 - There are repairs needed for the generator. This generator is also used for EMA purposes for the Borough. Chief Gantz is requesting assistance with the repair invoice.
 - R. Speigel moved to split the repair costs with the fire department at an approximate cost of \$1,000.00. C. Eshleman seconded the motion. Council was in accord and the motion carried.

- The Main and Manor project for signal lights.
 - o Close to completion. The concrete work is still under construction.
- Huntington Drive/Providence Place and Lemon Street repaving projects:
 - o The new curbing is complete. The area still needs backfilled, which should be completed any day.
- Spring Street Ordinance #306 to close the Spring Street railroad crossing
 - M. Auker moved to approve Mountville Borough Ordinance #306, Closing the Spring Street Railroad Crossing.
 C. Eshleman seconded the motion. Council voted 5 votes in favor (Auker, Baker, Eshleman, Kresge, Speigle) and 2 votes against (Eastep and Heisey) the ordinance, and the motion carried.
- Street Sweeping
 - Street sweeping will occur in Summit Hills only on December 4, 2023. This is a trial cleaning to make sure the company we plan to hire do sweeping in the future is cleaning to the satisfaction of Council.

 R. Speigel seconded the motion. Council was in accord and the motion carried.
- Auditor
 - There were two local firms solicited to become the next Borough Auditor. The Manager met with the two firms and gathered proposals from each. Both proposals were nearly identical, and the Manager would be comfortable working with either firm. The firms and proposals are as follows:
 - Bertz/Hess Lancaster \$12,500.00 for 2023
 - White/Rudy Elizabethtown \$ 9,500.00 for 2023

• C. Eshleman moved to hire White/Rudy to perform the Mountville Borough 2023 audit at a cost of \$9,500.00. M. Auker seconded the motion. Council was in accord and the motion carried.
